A new month. A new year. A new decade. Remember Y2K? The world was going to come to an end! Or at least the financial world. Our computers were all going to stop working. Financial disaster was eminent. Then January 1 clicked on the clocks. Computers still worked, banks still functioned, credit cards still showed how much money we owed.

Twenty years later, God is still firmly on the throne, sovereign and in control. 1 Timothy 6:15 tells us that, "he who is the blessed and only Sovereign, the King of kings and Lord of lords." (ESV) So, no matter what we faced in 2019 or what we may face in 2020, we can rest in the fact that God is sovereign; in fact, only God is sovereign. No one else. No person, not angels, not even Satan. Only God.

So, what does it mean when we say that God is sovereign? According to the New Oxford Dictionary, when used as a noun, sovereign is "a supreme ruler, especially a monarch." When used as an adjective, it is one "possessing supreme or ultimate power."

Supreme ruler? Ultimate power? Let's see. How about Napoleon, Alexander the Great, Stalin, Fidel Castro, Mao Zedong, Attila the Hun, Genghis Khan, Augustus Caesar, or Adolph Hitler? The tragedies that these men caused cannot be understated. They were horrendous—Hitler alone caused the mass murder of 5 million Jews and 6 million other minorities, along with the death of 12 million Germans. Think about it. One man had a part in the death of 23 million people. That's the population of 575 Coos County's, almost 6 Oregon's, or the population of Alaska, Delaware, Hawaii, Idaho, Kansas, Maine, Montana, Nebraska, New Hampshire, New Mexico, North Dakota, Rhode Island, South Dakota, Vermont, West Virginia, and Wyoming.

As much power and control that these men, and others like them, may have held, they did not possess supreme nor ultimate power. They were not sovereign. Ultimately, death held its personal victory over these men. Today, these men are but reminders to us of the terrible consequences of and the almost limitless nature of sin.

As believers, we have the assurance from 1 Timothy 6:15 that God is sovereign; in fact, he is the only one who is sovereign. We also have the assurance from 1 Corinthians 15:54-58 that death has been defeated by Jesus. Therefore, we are to be steadfast, immovable, always abounding in the work of the Lord. And we have the promise that our labor will not be in vain.

So, my beloved brothers and sisters—let 2020 be a year of fruitful labor for the Lord. It will not be in vain.

*Proverbs 21:5* The plans of the diligent lead surely to abundance, but everyone who is hasty comes only to poverty. (ESV).


2 Chronicles 15:7 But you, take courage! Do not let your hands be weak, for your work shall be rewarded. (ESV).
