Board minutes are summarized in the monthly *Lifeline* newsletter. Quarterly business meetings are set for the third Sundays in February, May, August, and November.

As moderator, my primary role is facilitating and equipping the board officers and standing committees to accomplish THEIR ministries and goals. Join me in expressing appreciation to every department chairman who has worked hard this year to accomplish the work of Christ's kingdom: Kelly Hoffine, missions; Penny & Ted Noble, membership; and Yvonne Woytus, worship. These departments are the underpinnings of all the ministry that flows outward to members, attenders, our community and our world. Randy Hoffine, trustees, and Sam Dickey, finance, oversee the church campus, the finances, and personnel. Elders Eric Ahlgrim and Randy Hoffine meet regularly to pray for the congregation and oversee the monthly prayer meetings on the first Wednesday of each month.

We started 2017 with ambitious plans to begin renovating and updating our church building. The trustees felt that we had the financial resources to get underway and the board developed a list of priorities. Rene Marler, Kelly Hoffine, and Jill Dickey volunteered to serve as a decorating committee to chose paint colors, flooring, and to make decisions regarding the upgraded restrooms. These gals spent hours pouring over samples and ideas to get us started on this project. The work will be completed in phases as money is designated or fundraising kickstarts some of the upgrades. The trustees are overseeing all this work and Rod Malcomb's crew has done much of the labor.

In March, Pastor Gary Rice announced his retirement. He served our church family with distinction for 12 years. The congregation approved seven members to serve as the Pastor Search Committee. We were pleased to welcome Pastor Roland and Nancy Shanks in August. From May to the end of July, Eric Ahlgrim arranged for pulpit supply and we were blessed with many excellent sermons from local preachers and some of our former pastors. I don't think the church family missed a beat in maintaining our fellowship and support of the membership.

Some highs and lows this year from my point of view:

HIGH: Attendance is up! **LOW:** Giving is down! I would challenge those who attend our church to prayerfully consider the support of our church. Stewardship of the resources that our Heavenly Father provides is a critical component of our walk with God. Hopefully we'll get some good teaching on this during 2018.

HIGH: Our Board members are dedicated to service! **LOW:** We have open board positions in Christian Education and Evangelism....both vital ministries of any Bible-teachin', Bible-preachin' church. All our departments need more volunteers to serve on their committees. Where is Jesus calling you to serve?

HIGH: We strongly support mission work in the Democratic Republic of the Congo; Beirut, Lebanon; International students attending University of Oregon; and locally, the Child Evangelism Fellowship. **LOW:** We support no other para-church outreach in our community and our mission giving is only 7% of our offering. Should we not aspire to more outreach in our community and world?

I've been serving as your moderator for three years and just about the time I believe the finish is in sight the Lord Jesus moves the finish line! So what is up with that? Our Savior is coming soon to call His saints into glory and to judge the nations of the earth. There are souls to be saved and suffering neighbors that need our light and love. 2017 Audit Report

Recommendations

The audit instructions need to be updated to accurately reflect the names of documents and items being compared.

Memorial Funds It is recommended to have one-person (or committee) count and deposit the money and a different person write the checks.

Fellowship Funds had a monthly offering slip missing but the total was accounted for in the bank statements.

It is recommended to not write checks to an individual but to where the money is going to. For example, if the church is helping with rent, make the check out to the landlord, not the person requesting it.

General Funds

Transfers need to be recorded the month the funds are transferred. It's also suggested to include a note at the bottom of the Financial Report the month a transfer is made indicating what the transfer amount is and what it is for.

If special designated funds are used for an expense, the expense needs to be paid out of the designated funds first and the balance paid out of general funds if necessary

All checks for deposit go through the financial counters. There was at least one check that did not get accounted for through the usual process.

A system needs developed to better track special designations and what those funds are to be used for.

The duties and responsibilities entrusted to the trustees include:

Finances: General Fund giving for 2017 was **\$129,125.98**. The projected budget expenses were **\$139,897.69**. The actual expenses were **\$131,504.00**.

This past year saw a lot of changes begin to take place. Pastor Gary Rice announced his retirement in the spring as the church was beginning to move forward on the large remodel project. The fellowship hall, sanctuary, and halls have all been painted, and now the bathroom remodels are underway. Flooring in the narthex, halls, fellowship hall, and kitchen will follow in 2018.

The Beckham Fund

The Beckham Fund is an endowment that was established in 2005 when Dow Beckham passed away. As of December 31, 2017 there is **\$116,016.00** in the endowment with \$5,228.00 available in 2018. These monies are used for the ongoing support of First Baptist Church. Historically, we have withdrawn \$3,000 annually to use for our copier lease payment. This past year we withdraw our maximum amount of \$18,826 with \$3,000 to go towards our copier lease and the balance of \$15,826 to go towards our church remodel project.

Dow Beckham was in the insurance business and was also a historian. Dow wrote several books, including: The Simpsons of Shore Acres, Oregon Indians: Voices from Two Centuries, Stars in the Dark: Coal Mines of Southwestern Oregon, along with several others.
